Strategic Highlights

The results were very positive in all areas including quality of care and professionalism. GAHA continues to have contracts with multiple Managed Long-Term Care Organizations (MLTCs) to provide home care for clients eligible for Medicare and Medicaid.

Financial Highlights

GAHA continues a growth trend with total revenue exceeding 3.5 million dollars in FY 2016, an increase of over 46% versus FY 2015. Income for FY 2016 was \$310,550, broken down as operating income \$301,250 and investment income \$9,300.

Operating Highlights

Billable service hours exceeded 190,000 hours for 2016, a growth of 52% since 2014.

MESSAGE FROM THE DIRECTOR

It is truly my privilege to work for an organization who prides itself in providing a high standard of care and who strives to meet the home care needs in our community. The dedicated home care team of Greater Adirondack Home Aides (GAHA) are amazing professionals who meet the daily challenges of home care while supporting GAHA's vision and mission for the community. These caring professionals are the foundation of the organization and are the key to our success.

In 2016, Greater Adirondack Home Aides continued to prosper with a total revenue exceeding 3 million dollars for the first time in our 60-year history! Total assets grew nearly 40%, while the agency experienced a 50% growth in billable service hours. GAHA's most significant growth occurred in the Consumer Directed Personal Assistant program (CDPAP). The agency has expanded our CDPAP service area to include Schenectady, Fulton, and Essex counties.

GAHA also implemented our annual patient satisfaction survey. The results are very positive in all aspects of patient care. Most patients surveyed were highly satisfied with services and would recommend our agency to others as a home care provider with high standards of care.

Greater Adirondack Home Aides would like to thank all our donors, including the Leo Cox Beach Philanthropic Foundation, and the Tri County United Way for their generosity in supporting our agency.

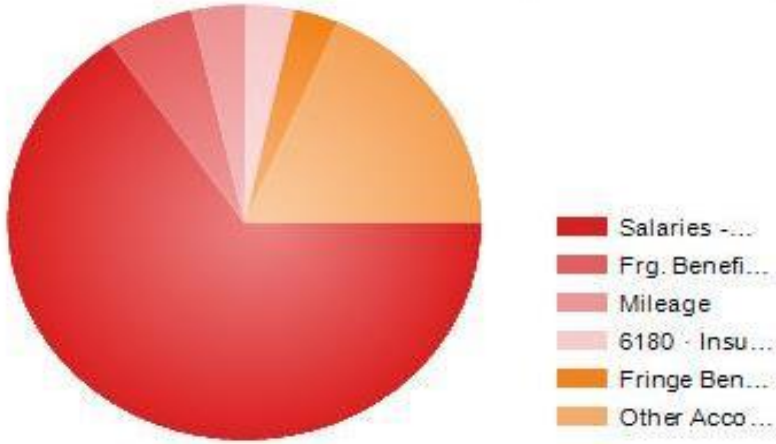

Income vs. Expense In \$1000s

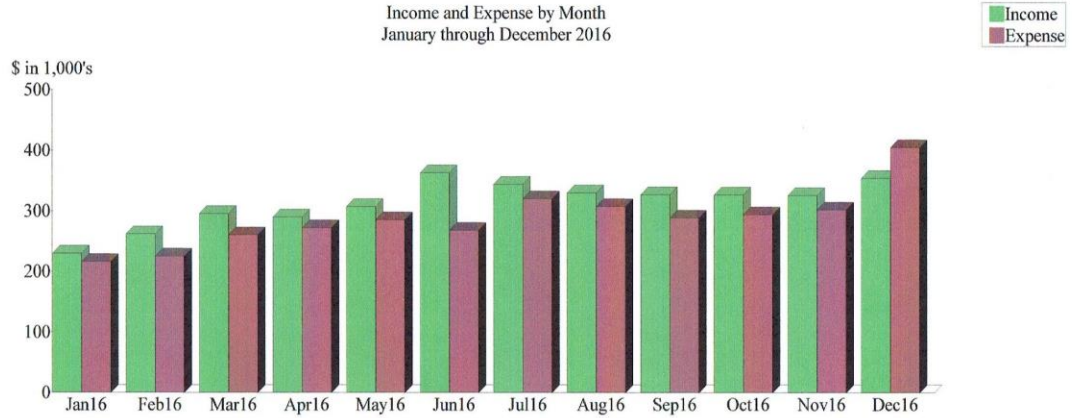




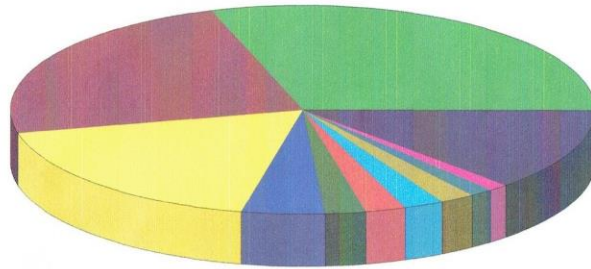

January through December 2016



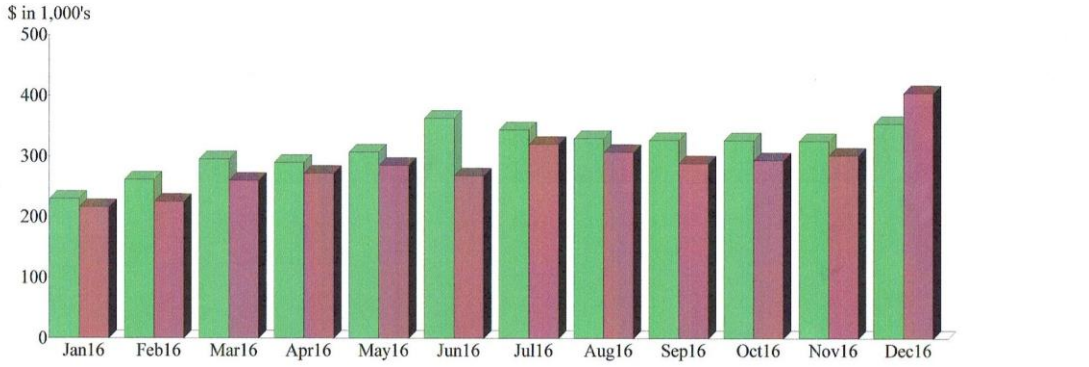

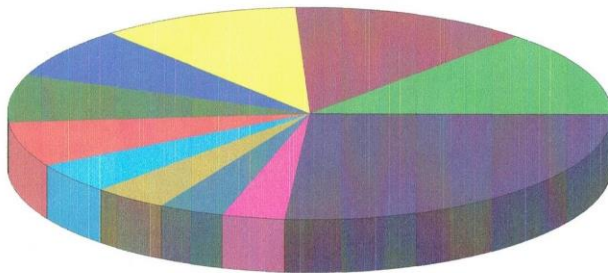
